4. If the election is contested, the poll will take place on **Thursday, 4th May 2017** between the hours of 7:00 am and 10:00 pm
5. Applications to register to vote must reach the Electoral Registration Officer by **12 midnight on Thursday, 13th April 2017**
6. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address shown below by **5pm on Tuesday, 18th April 2017**
7. Applications to vote by proxy at this election must reach the Electoral Registration Office at the address shown below by **5pm on Tuesday, 25th April 2017**
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the address shown below by **5pm on Thursday, 4th May 2017**. The physical incapacity must have occurred after **5pm on Tuesday, 25th April 2017**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after **5pm on Tuesday, 25th April 2017**
